

Campaign Terms and Conditions

1. Campaign Period

The **RAYA SELAMAT BERSAMA KELUARGA**("Campaign") commences from [00:00 a.m. on 11 May 2020 to [11.59 p.m.] on 26 June 2020 ("Campaign Period").

2. Eligibility

- (a) This Campaign is open to all Malaysians, aged 18 and above.
- (b) Eligible Participant who submitted a completed sign up form and answered the bonus questions at <https://www.greateasterntakaful.com/en/our-promotions-and-events/hospeefamily.html> during the Campaign Period and subsequently with in-forced certificate qualifies for participating in this Campaign.

3. Campaign Mechanism
